

# 1 CIVIL LIABILITY INSURANCE







- To insure the civil liability of the carrier
- Each vehicle used for the carriage of passengers is subject to insurance
- The carrier is liable to third parties for harm caused to life, health and property

# TECHNICAL RELIABILITY OF THE VEHICLE

- The technical condition of the vehicle must ensure road safety
- Only the owner is responsible for the technical condition of the vehicle.
- Technical inspection is required for vehicles used in passenger transportation business
- Pass technical inspection 2 times a year
- Pass inspection only at accredited diagnostic centers
- Check the status of the vehicle before each departure and on the road
- Only the owner is responsible for the mandatory vehicle inspection
- Inspection cost from 550 to 1000 soms
- The duration of the inspection from 15 to 60 minutes (but in practice it may take longer)

#### LIMIT OF LIABILITY FOR DAMAGE





- Inactive braking system
- Inactive steering
- Inactive (missing) headlights in the dark or in poor visibility conditions
- Inactive (missing) tail lights in the dark or in poor visibility conditions
- Inactive wipers during rain or snowfall



### THE MOST IMPORTANT POINTS DURING THE INSPECTION

- The body number is identical to the number in the data sheet
- Braking system
- Performance of the steering backlash
- Exterior lights
- Visual inspection of windshield wipers and washers
- ◀ Tire and wheel wear
- The amount of pollutants emitted (using a gas analyzer or smoke meter)
- No fuel leaks
- ◀ Fire extinguishers, warning triangle, etc.

### SAFETY IN ROAD TRAFFIC

- Follow the regime of work and rest of drivers
- Improve drivers' skills
- Conduct pre-trip medical examinations of drivers
- Improve first aid skills in case of an accident
- Passengers must wear seat belts
- Driving license of the appropriate category and professional work experience of at least 3 years (when carrying passengers by bus)



### IN CASE OF ACCIDENT THE DRIVER MUST

(ACCORDING TO ARTICLE 2.6 OF TRAFFIC REGULATIONS OF THE KR)



Immediately stop the vehicle, turn on the hazard warning lights and put an emergency stop sign



Take possible measures to provide first aid to victims. Call the "Emergency Medical Aid", and in case of emergency, send injuries on the way, and if this is not possible, take them by your vehicle to the nearest hospital, and return to the scene of the incident.



Clear the carriageway if the movement of other vehicles is impossible. If it is necessary to clear the carriageway or to deliver the injured on your vehicle to the hospital, preliminarily register the vehicle's position, traces and objects related to the incident in the presence of witnesses.



Report the incident to the police, write down the names and addresses of eyewitnesses and wait for the arrival of the internal affairs agencies

- To carry children under 12 years old in the front seat of the vehicle in without special child restraint
- To transport people in excess of the amount stipulated by the technical characteristics of the vehicle
- To carry cargo or baggage outside the baggage compartment
- To use the "right-hand drive" car for the commercial transportation of passengers, baggage and cargo
- To drive the vehicle in a state of alcoholic, narcotic or other intoxication
- To transfer control of the vehicle to intoxicated persons
- To drive the vehicle in violation of the regime of work and rest
- To talk on the phone using hands while driving
- In the standing vehicle to leave the doors open on the roadway side
- To exceed the speed (according to the road sign "Speed Limit" or according to the technical characteristics of the vehicle)
- To brake sharply (except for the prevention of accidents)
- When transporting passengers, at the same time to carry flammable, explosive, poisonous, caustic, poisonous and fetid substances, animals and birds

- Violation of the use of seat belts
- Exceeding the established vehicle speed by more than 10 km/h, but not by more than 20 km/h

- Driving the vehicle without technical inspection (mandatory for this vehicle)
- Driving without mandatory liability insurance of the owner of the vehicle
- Exceeding the established vehicle speed by more than 20 km/h, but not by more than 40 km/h
- Failure to comply with the requirements of road signs or road markings, violation of the rules for stopping or parking
- Talking on the phone while driving (except when conversation is possible without hands headphones, headset, etc.)
- Not following of safe distance, violation of the putting of the vehicle on the roadway or violation of traffic rules on highways
- Failure to comply with traffic regulations on stopping, in front of the stop line indicated by road signs or road markings, at a prohibitory signal of a traffic light or gesture of an authorized traffic controller
- Failure to provide advantages in the movement to pedestrians at pedestrian crossings, driving on pavements or pedestrian or a bicycle paths
- Violation of the rules of driving at intersections or driving on a prohibited signal of the traffic light or gesture of the traffic controller
- Violation of the rules for the use of external lighting devices or warning signals
- Violation of the requirements for the transportation of children established by the traffic rules

- Driving a vehicle with technical malfunctions which prohibit further use of vehicle
- Driving the vehicle by a person who does not have the right to drive such vehicle, or transfer control of such vehicle to a person who does not have the right to drive the vehicle
- Exceeding the established vehicle speed by more than 40 km/h, but not by more than 60 km/h
